Dear Representative Donalds:

I am writing to you in my capacity as President of the Gulf Shore Association of Condominiums (GSAC) to applaud your introduction of H.R. 1494 – the Hurricane Tax Relief Act – and to urge that you spare no effort in endeavoring to assure its passage by the House of Representatives.

As you may know, GSAC is an association of more than eighty condominium buildings in the city of Naples stretching from Doctors Pass through Naples Cay in the Moorings and Park Shore developments. Together our membership comprises more than 4500 individual residences, and our residents are your constituents.

Because these buildings are located directly on either the Gulf of Mexico or on Moorings and Venetian Bays, many of them sustained a great deal of flood damage from Hurricane Ian's storm surge. Now that tax time is upon us, many of our residents have received conflicting advice from tax lawyers and accountants as to whether, and when, they can claim a casualty loss on their 2022 tax return. At issue is whether Section 304(b) of the Taxpayer Certainty and Disaster Tax Relief Act of 2020 is applicable. As you know, that legislation would (a) waive the IRS requirement that any casualty loss must exceed 10 percent of AGI in order to qualify for a deduction, and (b) permit the taxpayer to claim a casualty loss without the need to itemize all other deductions.

The IRS instructions for claiming casualty losses (Form 4684), as last revised on December 30, 2022, are not helpful. They suggest that, in order to be a "qualified disaster loss," the event must be attributable to a federally-declared "major disaster" that occurred prior to February 25, 2021. Thus, though the instructions specifically mention Hurricanes Harvey, Irma and Maria (all of which occurred in 2017), even the December 30, 2022 revision does not reference Hurricane Ian -- despite the fact that FEMA declared Ian to be a "major disaster" on September 29, 2022, three months earlier (DR-4673-FL).

We greatly appreciate your efforts to address this apparent inequity, which, if allowed to remain uncorrected, would have a very significant effect on many of your constituents in the coastal communities of our section of southwest Florida. We also realize that Congressman Greg Steube, whose district includes the coastal communities immediately to the north of us, has introduced similar legislation (HR 1331), and that he is a member of the Ways and Means Committee, to which both his and your bill have been referred. While we realize that the House of Representatives has many issues of critical importance before it, we are optimistic that righting this easily correctable wrong will not become contentious. Through our communications with the thousands of residents we represent, we stand ready to assist your office in any way that you would deem helpful.
